EVENT WAIVER MUST BE SIGNED IN ORDER TO PARTICIPATE IN THE FUN RUN-WALK

For good and valuable consideration, including Participant's being permitted to participate in the FUN RUN/WALK ("EVENT") to be held on Saturday, May 7, 2011, I the undersigned participant ("PARTICIPANT") and I, the undersigned Parent or Guardian ("PARENT OR GUARDIAN") (where applicable), for myself, my successors, heirs, assigns, executors and administrators, forever release and discharge United Way of Southwest Alabama, and any political subdivision, entity or organization on whose property any part of the EVENT is being conducted, and also any other sponsor and all affiliates, subsidiaries, corporate parents, officers, directors, partners, employees, servants and agents of United Way of Southwest Alabama, and of any other sponsors (hereinafter individually and collectively in all combinations referred to as ("SPONSORS")) from all claims, causes of action, costs and judgments that I now or hereafter may have or claim to have for personal injuries, including death, damage to property, real or personal, caused by or arising out of PARTICIPANT'S involvement in the EVENT.
